Participation in the raffle can be made at Lizzie Baking Bird events by purchasing tickets with appropriate cash payment.

Any entries that are paid by Credit Card will be invalid and not entered into the draw. No refunds will be given and payment will be considered a donation to the charity.

No tickets can be sold to, on behalf of, or for a person under the age of 18 years. If a ticket is sold unknowingly to, on behalf of, or for a person under the age of 18 they will be exempt from the raffle and will forfeit their prize and the entry money will be returned to them.

Please keep your ticket or email receipt as proof of purchase.

Online entries will close at 1700 on Wednesday 10<sup>th</sup> December 2025. Cash entries will need to be with Lizzie Baking Bird by Sunday 14<sup>th</sup> December 2025, ahead of the draw on the same day.

Raffle tickets will be entered into the draw only when the whole payment is received.

Tickets received after Sunday 14<sup>th</sup> December will not be entered into the draw and payment will be treated as a donation to the charity.

Neither Lizzie Baking Bird or Weldmar Hospicecare will accept responsibility for raffle tickets which are lost, stolen, damaged or illegible, or from which the prize-winner cannot be identified, or for any technical failure or event which may cause the competition to be disrupted or corrupted.

Raffle tickets will be drawn randomly –physically and witnessed by two people. Anyone who has entered the draw will not be permitted to draw the prize-winning tickets.
